If you or someone you know wants to help define the direction of MMVI, consider a nominating them to serve on the Board of Directors. This exciting opportunity allows our members to use their skills and experience to serve the community and improve the lives of women, girls, and gender diverse individuals across Manitoba.

Due to Covid-19 restrictions, our AGA will be held on ZOOM and our election will be held electronically on Saturday, December 4, 2021 at 10:00 a.m. To prepare for electronic voting, all nominations must be submitted by November 16, 2021, 4:59PM CT. In contrast to previous years, there will be no nominations taken from the floor during the virtual AGA.

The deadline to submit nomination forms is Friday, November 16, 2021, 4:59 p.m. Please note: forms received after this date and time will not be considered.

Volunteer positions run for 2-3 years and board members are expected to commit between 5- 10 hours a month, or more for members of sub-committees.

At this year's Virtual AGM, there are five positions up for renewal:

- One Youth Position (two-year term)
- Four Board of Director Positions (two-year term)

Each nomination form must be completed in full and include the following:

- First and last name
- A short biography (500 words or less)
- The name and contact information of the nominee, their nominator, and seconder (all of whom must be members in good standing)
- Each nominee will be expected to make a short speech to the membership at the Virtual AGA, introducing themselves and sharing how their skills and experience would add to the effective governance of MMVI

- Be a female identifying person of Aboriginal/Indigenous ancestry.
- Be full voting members in good standing.
- Be 18 years of age or older (except for the youth representative who is between 16-29).
- Reside in the province of Manitoba, not be an undischarged bankrupt, or be employed by MMVI.
